<p>Progress has been mixed during 2019. The annual meeting with the Haytor/Bagtor element of DFF went favourably and the site meeting with the agencies was successful illustrating that by and large with a slight steer the farmers in this group could be left with minimal interference from agencies to achieve the majority of the objectives.</p>				
<p>A different outcome for the Forest. There were a number of meetings with the key Forest administrator to different units on the Forest. More increased Agency intervention was required to discuss and implement some of the vegetation work on the inner commons. As for the large North and South units some complacency has set in within the grazing group which has led to some fundamental under grazing issues and lack of management resulting in NE having to intervene in the main Agri-Environment agreement under pinning the FF. This was addressed during the AGM in autumn 2019 and the Forest Association will be putting measures into pace during 2020 hopefully with the Farming Futures as the continuing vehicle for self - management.</p>				
<p>As to the monitoring by the famers themselves, this was largely carried out by the Forest Administrator with a few commoners and was reasonably successful, this has been reported back to DEFRA through a separate self- monitoring study which will feed into the Test and Trials for the new ELMS.</p>

During 2019 there were 34 renewals including 5 Commons which will be extended in 2020 for a further year and maintain large tracts of Agri- Environmnetal land under agreement. It is not considered that it is practical or possible to retrospectively apply a peatland restoration PES scheme to the small area of Peatland restored on Dartmoor in the 2010-15 period. The trial scheme on Exmoor has not brought the expected returns in carbon investment via the peatland code or other avenues and the water quality benefits arising to SWW are thought to be less than £1/ha. As a result of this SWW will not be seeking to extend the existing agreements when these expire on Exmoor or set up new ones on Dartmoor. Status Completed</p> <p>Update 2. for the new areas of restoration which are being carried out on Dartmoor under the Defra Funded project a new partnership approach has been developed, so SWW is no longer the lead developer, it is facilitating the restoration with capital works funding from Defra and staff support from DNPA. As such there is no interest in claiming the carbon benefits arising from the restoration via a new PES payment scheme. This creates a new opportunity for the owner of the land and carbon (the Duchy of Cornwall) and the Commoners to work together to develop a carbon reward scheme through the use of the IUCN peatland code. This is being investigated and considered by the Duchy as the lead. Assuming these will be implemented as written then the any proposed felling and restocking should be sympathetic to the local landscape character. Ausewell Wood has been acquired in partnership by the Woodland and National Trusts, and management Plans are being received for future management.</p> <p>WT - The restoration of Plantations on Ancient Woodland Sites (PAWS) forms the main part of the Woodland Trust's work around Dartmoor which intrinsically improves the aesthetic value of these woodlands. One example at Houndtor Wood in the Bovey Valley demonstrates where thinning of conifers has improved the view from Trendlebere Down to Houndtor Ridge. Dartmoor Natural Flood Management Pilot: We have appointed a joint EA and DNPA Project Officer who is responsible for the day to day running of the project. We are still progressing with options in the Mardle, Dean Burn and Peter Tavy Catchments. Devon County Council are responsible for delivering work at Hanger Down, Ivybridge and we are awaiting a proposal from Westcountry Rivers Trust for work at Walkhampton. The project has identified a number of sites within the Mardle and Peter Tavy catchments which lend themselves to gully blocking and tree planting. We have local land owner buy in and hope to progress these options to the delivery phase shortly. A local landowner within the Dean Burn catchment has come forward with a proposal to plant trees on his land. The project will help pay for the procurement and planting of these trees and we hope the work will take place during the second week of February.

Dartmoor Dips - Sheep Dip Project: The increase in Sheep Scab on Dartmoor has seen a return to dipping sheep to prevent cross contamination and ensure their welfare. Dartmoor Hill Farm, Westcountry Rivers Trust and Environment Agency collaborated in project to assess true extent of sheep dipping and potential impact on water quality. This has resulted in some industry wide action to enable the cost effective implementation of sheep dipping solutions. The project has been completed.

Upper Teign Fish Habitat Improvement: We have supported the Teign Angling and Conservation Association and West Country Rivers Trust in a significant National Heritage Lottery Fund bid. If successful, a four year partnership programme of works to improve fish habitat will be undertaken. The partnership also includes National Trust and Westcountry Rivers Trust.

Upper Teign Fish Easement: Through the Catchment Partnership we have hosted a number of planning workshops to identify barriers to fish passage and fish habitat improvements. These have been added to a programme of works for each waterbody for delivery from 19/20 onwards. A detailed design has been proposed for the first of these improvements during 2019 and once approved by all stakeholders, we will seek to implement the improvements during 2020. Westcountry Rivers Trust are leading the project in partnership with the Environment Agency which includes a bid for European Maritime Fishery Funding.

Head wall and culvert Improvements (daylighting) on Walkham: We have identified an opportunity to reduce sediment mobilisation and reduce impact of wastewater from abandoned metal mines on a tributary of the Walkham. The site at Horrabridge presents an opportunity to improve the confluence of this tributary, remove a culvert and create and open channel to improve value to both the local community and habitat. The project is being led by the Environment Agency Asset Performance team. An initial design is expected to be delivered by March 2020.

3 Rivers Project: This project is now in its 3rd year and aims to support and promote best practice amongst riparian landowners including agriculture and

forestry. The project includes promoting awareness amongst the different sectors, attracting match funding to enable physical interventions and improvements to be undertaken. The improvements contribute to reducing pressures on the Walkham water body and improving Water Framework Directive Failures. The project, led by the Westcountry Rivers Trust in partnership with the Environment Agency also included a Woodlands, Water Quality and Fisheries workshop at Eggworthy early in 2019 attracting over 30 key stakeholders.

Strategic Monitoring Review: We have been conducting catchment pilots to improve the efficiency and scale of our monitoring network. One pilot was conducted in the Tamar where we worked with several catchment partners to identify data and information gaps and prepare joint plans to deliver targeted monitoring. This approach will be rolled out throughout the catchments over the next few years. Supplementing this pilot we have trialling the benefits of publishing water quality data via our Catchment Data Explorer on a triennial basis. The next update of data is expected during or before April 2020.

The Dart, Tamar and Fernworthy catchments continue local engagement with landowners in the final months of the Upstream Thinking Project, the current round will close in March 2020. The key driver being improvements in surface water quality in rivers, streams and other waterbodies which feed into local drinking water supply. Joint delivery on the ground between Westcountry Rivers Trust and Devon Wildlife Trust has seen significant coverage and investment in the last 5 years in these catchments. These have delivered farm advice, soil testing, capital grants and training workshops.

Focus is now very much about demonstrating the full and varied benefits which have resulted from this work as case studies and 'proof of concept', not only to support water quality but also how this has also delivered economic savings for farmers, ecological gains etc. The delivery partners are currently in negotiation with South West Water as the funder, to develop the next 5 years of investment which is anticipated to have a greater focus on bolstering Biodiversity or Carbon benefits, Flood mitigation (such as temporary water storage) or Woodland planting alongside water quality itself. Dartmoor presents opportunities for multiple benefit outcomes; Upstream Thinking aims to continue supporting upland farmers to manage their land and grazing as well as signposting to other schemes or initiatives where possible to optimise outcomes for all involved.

Highlights over the past year have included further work with the Devon Recovery Learning Community which has resulted in deeper learning for the participants and Butterfly Conservation, working with partners to provide an engaging field trip for local school children, and recruiting new volunteers via our workshops to help with species monitoring. The project has continued to work in partnership with key partners to ensure that the best is made of shared resources, which resulted in the following events in 2019: guided walk with the National Trust and Greater Horseshoe Bat Project, attending DNPA public events at Haytor and Meldon, delivering workshops with Natural England at Yarner Wood. In addition to the habitat management delivered by volunteers (mentioned above), a programme of funded habitat management work (carried out by contractors) was also delivered in 2019. During the winter of 2018/19 scrub was cleared at Castle Drogo to improve conditions for the Pearl-bordered and Small Pearl-bordered Fritillary. More scrub control is planned here for the winter 2019/20. Additional funded work has taken place during the winter of 2019/20 at West Down for the High Brown Fritillary, Lower Hurston Farm for the Marsh Fritillary and Dunsford nature reserve for the Pearl-bordered Fritillary.</p>

The Devon Recovery Learning Community (an NHS partnership trust) courses are provided for people who have had mild to severe mental ill-health and are on a journey to recovery, past courses have included people from the following categories: living in areas of social deprivation; unemployed; low income; people with poor health and disabilities; BAME and LGBTQi people. Devon Recovery Learning Community courses are co-tutored by outdoor or other practitioners accompanied by co-tutors with 'lived experience' of mental ill-health.

Devon Local Nature Partnership - Naturally Healthy working group: DNPA (and ENPA) sit on both forum and steering group for this topic group that meets to take action on integrating health and wellbeing with blue-green space. It draws membership from across both the environmental conservation sector and health professionals. Currently D LNP is chaired by a GP.

SWEEP (the South West Partnership for Environment & Economic Prosperity) - sub-strand of work: Informing environmental investment for health and wellbeing. A two year funded project reviewing evidence to translate evidence on interconnections between natural environments and health in order to inform decision making on environmental investment and management for health outcomes.

Staff engagement - especially in 2019; Year of Green Action: a variety of initiatives throughout the year to help staff engage and develop meaningful relationships with the environment (through conservation volunteering) with each other and with themselves.

The original Dartmoor Diploma project was successfully re-scoped in early 2017 into two projects: PD4 – Heritage Skills Training and PD5 – Conservation Apprentices, both led by DNPA

Heritage Skills - has delivered 41 courses to 480 people, the target was 36 courses to 180 people. So the project has far exceeded targets, feedback has been very positive, the project has been well run and is under budget. Relationships between DHFP, landowners/managers and local people have been strengthened. There is support to continue with Bee Keeping, Sheepdog training and Walling beyond the initial project term.

Conservation Apprentices – two have completed and gained employment, one is still with us.

Devon County Council continue to collaborate with all partners, listed above, to ensure flood risk is managed appropriately and where possible to reduce the risk of flooding to properties and the wider communities. The Devon Community Resilience Forum is now well established and offers opportunities to support communities in developing Emergency Plans and the provision of essential equipment to assist during an incident. The recent storm events in early February 2020 delivered significant rainfall over Dartmoor causing severe disruption to many communities, including Bovey Tracey and Ashburton. It is likely that the emergency plans and flood protection measures, delivered in the Dartmoor communities, provided some level of reassurance for the residents. The Dartmoor Headwaters Project, led by the Environment Agency, is continuing to gather momentum. Five catchments including Dean Burn, Walkhampton, Peter Tavy, Mardle and Ivybridge are included in the project which will consider the implementation of Natural Flood Management (NFM) measures. Devon County Council are leading on the Ivybridge measures at Hanger Down and the baseline monitoring is well underway. Good results are being established for the baseline conditions which will provide evidence of any benefits gained from the proposed NFM measures, which are now to be implemented during 2020. These will supplement the flood prevention works proposed within Ivybridge now being constructed.
