Steering group meets once a year to review the 10 outcomes of DFF. Facilitator of both the Forest of Dartmoor and Haytor/Bagtor element of DFF have reported findings to Steering meeting and have shown some positive facilitation of the objectives that they have been managing the Project with limited agency interference. An annual meeting with Natural England is convened and any joint actions are put in place by the two groups in the following year.

Monitoring of both vegetation and stocking levels is attained by the DFF project and this data will be available in feeding into the various tests and trails for the new Environmental Land Management Scheme. The announcement of these test and Trails has just been announced ad it list DNPA and the DFF as a possibility subject to DEFRA ratification in February 2019.

Two different actions are now arising;

- 1. for the area of peatland restored by the Dartmoor Mires Project 2010-15, led by DNPA but funded by SWW a peatland restoration PES scheme based on the principles of the with the one rolled out on Exmoor will be applicable to the restored areas on Dartmoor. The data from the Dartmoor monitoring sites will be used to calculate the possible value of the ecosystem services provided by the restoration which has been carried out on Dartmoor and to price this accordingly within a future scheme. The time scale for this work remains at least 3 years post restoration, the longer the run of data the better the valuation of the services provided will be. Following the review of data in January 2018 a decision will be made if this is enough data to base the scheme on.
- 2. for the new areas of restoration which have been proposed on Dartmoor under the draft Defra Funded project a new payment scheme led by the Duchy of Cornwall though the IUCN peatland code is being investigated.

Progress continues as above with work continuing at both Burrator and Fingle Wood, A further 368 hectares of privately owned woodlands have had UKFS compliant management plans approved. The main development this year has been the revision of the Forest Enterprise Dartmoor Forest Plan. This covers the forests of; Fernworthy, Soussons, Bellever and Brimpts totalling 1388 hectares. The plan revision has identified the most intrusive forest edges and shows an intention to reduce the impact and deliver a more integrated landscape. Conifer levels will be reduced over the next 10 years by converting 36 hectares to open ground and mixed broadleaves.

Thankfully 2017 has seen a slowdown in the spread of Phytophthora ramorum with the need for only 3 SPHN's to be served within the Park boundary to date, although 3 more sites remain under investigation. The outbreak map continues to be updated on a regular basis. Outbreaks of Chalara continue to be found throughout the South West although no new cases have been reported within the Park. E-alerts remain the most reliable method of disseminating updates and TreeAlert remains the most effective way for all tree health outbreaks to be reported. The Forestry Commission's Tree Health team have appointed a Tree Health Regulations Officer in the SW to help with the continuing workload.

#### **Update 2018**

Dartmoor Natural Flood Management Pilot

We have appointed a joint EA and DNPA Project Officer who is responsible for the day to day running of the project. We are still progressing with options in the Mardle, Dean Burn and Peter Tavy Catchments. Devon County Council are responsible for delivering work at Hanger Down, Ivybridge and we are awaiting a proposal from Westcountry Rivers Trust for work at Walkhampton. The project has identified a number of sites within the Mardle and Peter Tavy catchments which lend themselves to gully blocking and tree planting. We have local land owner buy in and hope to progress these options to the delivery phase shortly. A local landowner within the Dean Burn catchment has come forward with a proposal to plant trees on his land. The project will help pay for the procurement and planting of these trees and we hope the work will take place during the second week of February.

#### Dartmoor Dips - Sheep Dip Project

The increase in Sheep Scab on Dartmoor has seen a return to dipping sheep to prevent cross contamination and ensure their welfare. Dartmoor Hill Farm, West Country Rivers Trust and Environment Agency collaborated in project to assess true extent of sheep dipping and potential impact on water quality. This has resulted in some industry wide action to enable the cost effective implementation of sheep dipping solutions.

#### Water Environment Grant Fund

A £27m fund based on Rural Development Programme of England was announced in March with a call for bids for May 2018. A bid was submitted for a £350k "Cleaner Teign" project but due to the large number of bids submitted was unsuccessful. The project has been captured and added to the future Environment Programme.

## **Upper Teign Fish Easement**

Through the Catchment Partnership we have hosted a number of planning workshops to identify barriers to fish passage and fish habitat improvements. These have been added to a programme of works for each waterbody for delivery from 19/20 onwards. We have been in a position to accelerate one of these fish easements on the Upper Teign, near Chagford, delivering the design phase in 18/19 with construction in 19/20. Westcountry Rivers Trust are leading the project in partnership with the Environment Agency which includes a bid for European Maritime Fishery Funding.

Head wall and culvert Improvements (daylighting) on Walkham.

We have identified an opportunity to reduce sediment mobilisation and reduce impact of wastewater from abandoned metal mines on a tributary of the Walkham. The site at Horrabridge presents an opportunity to improve the confluence of this tributary, remove a culvert and create and open channel to improve value to both the local community and habitat. The project is being led by the Environment Agency Asset Performance team.

#### 3 Rivers Project

This project is now in its 3rd year and aims to support and promote best practice amongst riparian landowners including agriculture and forestry. The project includes promoting awareness amongst the different sectors, attracting match funding to enable physical interventions and improvements to be undertaken. The improvements contribute to reducing pressures on the Walkham water body and improving Water Framework Directive Failures. The project is led by the Westcountry Rivers Trust in partnership with the Environment Agency.

#### Strategic Monitoring Review

We have been conducting catchment pilots to improve the efficiency and scale of our monitoring network. One pilot was conducted in the Tamar where we worked with several catchment partners to identify data and information gaps and prepare joint plans to deliver targeted monitoring. This approach will be rolled out throughout the catchments over the next few years. Supplementing this pilot we have trialling the benefits of publishing water quality data via our Catchment Data Explorer on a triennial basis. The next update of data is expected in June this year

#### Future Environment Programme 2020/21 – 2026/27

We have completed our indicative submission for the future funding settlement for the Environment Programme for Devon, Cornwall and Isles of Scilly. This has included the development of a long term vision, noble causes and the future outcomes expected. A robust and challenging works programme, comprising revenue and capital activity to improve water bodies from source to sea, has been prepared and submitted to our National Environment Programme team.

The project continues to offer habitat management advice to farmers and landowners in appropriate management for the target fritillary species, and support to Natural England in the preparation of new Countryside Stewardship agreements. During the period January 2018 to December 2018 (Year 2 of the project), 150 site visits have been made to 78 Dartmoor sites to offer advice, undertake monitoring or carry out practical habitat management. These have been carried out by a combination of Butterfly Conservation staff and volunteers. Assistance has been provided to Natural England on a number of Countryside Stewardship agreements, as well as working with partners (such as the National Trust and Devon Wildlife Trust) and private landowners to provide management advice. The close relationship with the DNPA has been maintained through working together on delivering monitoring of key sites, as well as working in partnership to deliver funded works on certain key butterfly sites. Butterfly Conservation has also provided input into various discussions that have taken place on farming and land management related issues, including: DNPA Visioning workshops, DNPA management plan discussions, Dartmoor Advisers meeting on the economics of upland farming and Common Cause workshop.

This is looking at the work advised by the Coppins and Devon Lichen group, and completed in earlier years. Neil reported on the improvement on the habitats over the duration of the scheme.

MTMTE PA4 – Discovering the Nature of the Bovey Valley: Barbastelle Bats: Overall the main elements of the bat work and woodland restoration are complete and we are now in a phase of reviewing the work undertaken and summarising this in the form of reports. The main focus of activity has been "cleaning" the iButton data (2.5 million records) into a functioning database which can be interrogated, much of this work is being delivered by a volunteer. Bristol University are beginning to make use of the data as part of a study of wood warblers, which is an additional output to our original plan. In addition, we continue to undertake restoration activity which is additional to the original plan. This additional work will add greatly to the overall project delivery. Lichens: The original site work is complete to assess dispersal potential and secured lichen management of up to 10 ha of the wider landscape. Some additional activity is planned and grazing is ongoing. After felling and clearance, the work of restoration involves ongoing management in some parts of the reserve by Dartmoor Ponies - presently working on viability of grazing Vinnimore area; site of the 2017 community archaeology excavation.

MTMTE PA1 – Moorland Bird Advisor: the original project was re-scoped in Jan 2017 to appoint a Moorland Bird Advisor working 50% in the MTMTE area and 50% across wider Dartmoor. The Project feels well established with much broader links across the farming community and is working closely with many other organisations and initiatives on the moor (e.g. Operation wader, Dartmoor Advisors group, Duchy Natural Capital Officer, Dartmoor Farming Futures, Butterfly Conservation, Our Common Cause, Natural England). The Project is fully engaged with the Operation Wader aspiration to rescue the failing curlew population on Dartmoor and is well placed to help guide and deliver the habitat management changes required in the Central newtake and Haytor areas and potentially help find and supervise any volunteers required for this initiative. Progress has been made in both these areas of Dartmoor, with farmers very open to discussion; management changes have been agreed in several newtakes with further capital works planned this winter. It is clear that the next few years are going to be a time of change on Dartmoor with a gradual shift in focus within the agri-environment landscape. This offers opportunities to review management, particularly where it has clearly not been beneficial. The Project is in a position to help guide trials which can help inform management elsewhere on the moor. However, there are challenges and sensitivities and many farmers are anxious about the future and unwilling to consider changes to management and wary of falling-foul of their agri-environment scheme. The Project has to operate in a way that respects these uncertainties and during a time of transition in terms of their relationship with Natural England offer as much support as possible.

The Dart, Fernworthy and Tamar Upstream Thinking Projects are nearing the end of Year 4 (of 5), which means a good level of engagement with local landowners, farmers and communities has ensured continued momentum in these catchments towards the objective of improving water quality which contributes to local Drinking Water Supply. The delivery Partners; Westcountry Rivers Trust & Devon Wildlife Trust collaborate to offer free and confidential Integrated Farm Management Plans, Countryside Stewardship applications, Soil Sampling & Nutrient Planning. These support the ambition for working landscapes which can continue to operate productively whilst also supporting or enhancing our natural resources – not only water supply and quality, but also levels of biodiversity. Works are supported where possible by capital grants and a suite of monitoring to understand and demonstrate positive outcomes, whilst working closely with other initiatives for efficiency such as the Dartmoor Hill Farm Project to provide tailored workshops.

The nature of catchment management means continued planning and a focus on developing what the next 5 years of delivery and funding may look like, through Partnership input together with South West Water. As Dartmoor is the source of a number of important rivers, it's inclusion in future programmes is key to ensure a sustainable future for local communities and their natural resources.

The 'All the Moor Butterflies' project began in January 2017, with two full-time staff being appointed (a Conservation Officer and a Community Engagement Officer). During Year 2 of the project (2018) the project has delivered the following: 13 volunteer habitat management work parties, 9 butterfly ID and survey training workshops, 5 landowner events, 4 guided walks, 2 public events, 5 moth nights, 4 talks, and 4 primary school workshops. In total these events have resulted in 426 people encounters, 241 children encounters, and 160 volunteer encounters. The volunteer work parties continue to be successful, attracting good numbers of volunteers who help carry out vital management work on sites where it is most needed. Highlights over the past year have included working with Devon Recovery Learning Community to offer a 3-part wellbeing course focused on 'Butterflies as a Metaphor for Recovery', working with partners to provide an engaging field trip for local school children, and recruiting new volunteers via our workshops to help with species monitoring.

DNPA currently working with Airband on pilot for new airfibre scheme (local fibre optic delivery with wireless backhaul) on Dartmoor as one of 3 CDS community pilot projects.

Another community pilot also took place on Dartmoor at Harford which looked to a BT fibre solution. This is now complete.

BT gainshare monies are also likely to benefit Dartmoor over next 12 months or so but final coverage is still to be determined.

Devon Rural Housing Partnership has continued to work with local communities to identify housing needs and opportunities to deliver these.

- A housing need survey for Dunsford is planned for March 2019. The report should be completed by May 2019 and it is hoped that further work on developing an affordable housing project to identify any local need can proceed following this.
- \*Lydford Parish Council has not responded to an offer of a housing need survey. We will follow up this approach to see if we can arrange a meeting to discuss.
- \*Moretonhampstead has completed their own housing need survey. However this does not contain any verifiable housing need information. The Housing Need specialist from DRHP has provided a critique that is being used as a starting point for discussion with the community.
- \*Discussions are underway with Princetown about carrying out survey.

The RHE has worked closely with Cornwood Parish Council to help them to consider their options for meeting their identified housing need. The parish is currently considering whether to follow the community led approach or to work with Southwestern Housing Society. A visit for the RHE to accompany some members of the Parish Council to some Southwestern Housing Society homes has been arranged for March.

#### Update 2018

Devon County Council continue to collaborate with all partners, listed above, to ensure flood risk is managed appropriately and where possible to reduce the risk of flooding to properties and the wider communities. The Devon Community Resilience Forum is now well established and offers opportunities to support communities in developing Emergency Plans and the provision of essential equipment to assist during an incident. Despite a prolonged period of wet weather at the end of 2018 there were no major incidents as a result, therefore the emergency plans and flood protection measures, delivered in the Dartmoor communities, have not been fully put to the test. The Dartmoor Headwaters Project, led by the Environment Agency, is gathering momentum. Five catchments including Dean Burn, Walkhampton, Peter Tavy, Mardle and Ivybridge have been chosen for the implementation of Natural Flood Management (NFM) measures. Devon County Council are leading on the Ivybridge measures at Hanger Down and the baseline monitoring is now underway. Once the baseline conditions have been established the NFM measures will start to be implemented late summer of 2019. These will supplement the flood prevention works proposed within Ivybridge, also being delivered in 2019.
